**BACKGROUND**

The City of Crescent City since 1997-98 has been in violation of Cal. Const. Article XIII D and Proposition 218. The City has failed to notify parcel owners of any sewer increase, failed to hold public hearing no less than 45 days after notifying parcel owners of any increase in sewer rate, and allowing a written protests against the proposed fee or charge are presented by a majority of owners of the identified parcels, thus denying the citizens due process under U.S. Const. XIV § 1.

I am asking for a refund for the past year, the difference between the current rate and 1998 water and sewer rates, since the City of Crescent City is not in compliance of Ca. Const. XIII D § 6, increasing in sewer rates without sending notices to owners and/or rate payers and allowing the owners and/or rate payers the opportunity to protest is unconstitutional and illegal, thus denying the people their right to due process pursuant to U.S. Const. XIV § 1.
